We are grateful for the community of vendors who attend and together create the Daniels Farmstead Farmers' Market; participation as a vendor requires commitment to the Sunday Market Season.

The Farmers' Market Season begins on the first Sunday of July and continues through each Sunday (rain or shine), to the first Sunday of October. Special events are held throughout the season, and are most often hosted in conjunction with the Farmers' Market. In addition to Sunday Markets, the Daniels Farmstead Farmers' Market special events are well attended.

VENDOR RULES AND REGULATIONS

Please Read carefully.

Daniels Farmstead Sunday Farmers' Markets are open to the public 11:00am to 2:00pm. Vendor fee includes one 10' by 10' stall. Vendor Space is limited. Participating vendors will supply their own table, chairs and tent.

Daniels Farmstead Farmers' Market vendors are local, selling only locally grown and or locally made products.

The vendor shall not leave their space unattended at any time during operational hours of Markets. Site manager will not provide security and will not be responsible or liable to vendor for loss of any kind at Markets or Events.

Each participating vendor must have "space" setup completed prior to 10:45am at each Sunday Market attended.

Daniels Farmstead Market Vendors selling food products must have ServSafe Certification/Allergen Awareness Training from town Board of Health and provide copy of certification. Smoking is not permitted on Site.

Daniels Farmstead Farmers' Market Site management reserves the right to change these policies at anytime (*Notice will be given of any said changes*).
